The delivery date is Saturday Dec. 1, from 9 AM to Noon. Entry fee is \$10 per work, two pieces may be entered per member. The maximum size is 16" in any direction, including frame or support. Subject and media are your choice; ceramics and sculpture are permitted.

Judges have been selected from our talented instructor pool and the judging will be anonymous, both before and after the show. Cash prizes will be awarded at the Holiday Luncheon on Dec. 12. Artwork may be no more than 2 years old, and must be original. No piece may be entered if it has previously won an award in any Artists' Workshop judged exhibit. Refer to "Rules about exhibiting at the Gallery on Canal" in the 2018 Membership Directory for art work preparation requirements. Please secure a card with your ID information on the back.

61st Annual Members' Show:

"Passport to Paris"

Annual Members' Juried Show Rules and Information: On January 19th, 2019, AWI presents the Juried Annual Members Show, "PASSPORT TO PARIS", opening with a cocktail reception to be held in The Marilynne Roland Studio Gallery, and Studios A, and B. Classes normally held in these studios will be cancelled beginning on January 14 through January 20. Classes will resume on Monday, January 21.

The painting and creating theme is open to your choice of subject, while the decor and mood is influenced by a night in Paris. Think bistros, street artists, cafes and dressing the part. Let's have fun!

The Prospectus with labels, and important information will be made available to eligible members on our website this year. You can print your copy from the site. Copies will be available at General Meetings, the Studio Workshop, and the Canal St. Gallery as well. Notice will be published in the newsletter and on the website when the Prospectus becomes available in December.

Entry Date and Information: January 14, Monday, 9am until Noon, will be intake for this show. Judging will follow at 2pm sharp. No late entries accepted due to judging schedule. Please add this important date to your calendar.

Entry fee for the Annual Members Show is \$25. One entry only. Bring your entry with completed labels attached to the back of your 2-D pieces. 3-D pieces provide labels to be place under the piece or with it.

Mats must be white, off-white, gray or black only. Simplicity in framing is critical when judging. Proper wiring is required. Please keep this in mind.

Size limitations apply. 2-D work may not exceed 36 inches in any direction including frame. 3-D work must fit on a pedestal no wider than 12 inches with a few exceptions determined by the chairman. The new display cabinet allows for more variety in 3-D pieces with weight and size restrictions. Please consult the Chairman. Smaller works are encouraged to allow as many members as our space allows to be a part of this show. Miniature paintings are encouraged. These paintings can have a frame with an easel back to display on the pedestals or in the new shelving in Studio C, the Marilynne Roland Gallery.

Eligibility: Rules for this show are in the By-laws in the new 2018-19 pink members directory. AWI dues must have been paid and recorded by October 19, 2018, 3 months prior to date of Show to be eligible to enter. (Article X, By-laws, p. 49,)

In order to maintain the professionalism, as in the past, and to limit the number of entries to fit the space allowed, this show is Juried. (Article IX, By-laws, p. 49)

Only Original artwork in oil, acrylic, watercolor, pastel, drawing, mixed media, fiber art, photography, or sculpture will be accepted that meet with the requirements outlined above along with the following rules. Artwork must be of the artists own concept and design. Artwork that has been previously shown in an Annual Members Show, has won an award in an AWI Judged Show, or is over 2 years old will not be accepted. We rely on Members integrity to enter work that is independent of instruction by a teacher. Artwork found to be copied from other artists work will forfeit any awards. (Article IX, By-laws, p. 49) We reserve the right to remove any entry not in compliance with eligibility rules. No refund will be issued. "Waiver of Liability" forms must be completed upon entry of artwork. We handle your artwork with great deal of care but cannot be held accountable for loss or damage. Be sure to insure your own work.

AWI may use images of exhibited works on our website, and in publicity materials giving credit to the artists.

Awards: Presentation of awards will take place at the show opening January 19, 2019, during the Gala, "Passport to Paris". More information on the evenings lineups will be published at a date closer to the event.

Judge: Dr. James Murphy has kindly accepted an invitation to be the juror for the AWI 61st Annual Members Show. James J. Murphy is a former educator and arts administrator, most recently as adjunct professor of art history at Stetson University. He has held full-time and adjunct positions at the University of Alabama, Daytona State College, Valencia Community College, and at Florida State University, where he also served as chairman of the Department of Art.

Dr. Murphy was the first program director of Atlantic Center for the Arts, an interdisciplinary artists' community, and served as executive director of the Society for Photographic Education. He has been an independent curator to arts organizations, and is the author of reviews, articles and catalogue essays. Dr. Murphy attended Saint Peter's College, where he was a member of the Honors Society and the first graduate of the College in Art History. He holds a M.A. and Ph.D. degrees in Art History from Florida State University, completing his graduate research in the FSU Florence Study Program in Italy.

Dr. Murphy has judged many art shows for us in the past and at other local venues. As artists, we welcome his expertise, and his presence, at our gala presenting the awards and commenting on our works of art.


From the President
